



## **BURSA ANYWHERE APP AND eSTATEMENT SIGN-UP CAMPAIGN 2.0**

### **TERMS & CONDITIONS**

The Bursa Anywhere App and eStatement Sign-up Campaign 2.0 (hereinafter "Campaign 2.0") is organised by Bursa Malaysia Berhad, 1976197601004668 (30632-P) ("Bursa Malaysia"). Campaign 2.0 is governed by these Bursa Anywhere App and eStatement Sign-up Campaign 2.0 Terms and Conditions (hereinafter "Terms and Conditions"). By participating in Campaign 2.0, participants agree to be bound by all the terms and conditions below.

#### **Campaign 2.0 Period**

1. Campaign 2.0 commences on **01 April 2022** and ends on **31 December 2022**, inclusive of both dates ("Campaign 2.0 Period").

#### **Eligibility**

2. Campaign 2.0 is open to existing CDS direct account holders of Bursa Malaysia who are receiving paper base statements and have yet to opt in to receive electronic statements ("eStatement") as of **31 December 2021** ("Eligible Depositors").
3. CDS direct account holders of Bursa Malaysia whose accounts are closed or suspended are not eligible to participate in Campaign 2.0. Eligible Depositors whose accounts are closed or suspended during the Campaign 2.0 Period will be disqualified from participating in Campaign 2.0 and receiving the Campaign 2.0 gift specified below.

#### **Campaign 2.0 Gift**

4. Bursa Malaysia is offering a Touch 'n Go eWallet reload pin worth Ringgit Malaysia Five (RM5) ("TnG Reload Pin") to Eligible Depositors who meet the following requirements during the Campaign 2.0 Period:
  - (a) Download and complete registration with Bursa Anywhere ("BA") mobile application; and
  - (b) Enrol or register to receive eStatement.
5. Each Eligible Depositor is only entitled to receive one (1) TnG Reload Pin. An Eligible Depositor with more than one CDS account and/or have provided different e-mail addresses to receive eStatements for each or some of their CDS accounts is still only entitled to one (1) TnG Reload Pin.



6. Bursa Malaysia will issue the TnG Reload Pins to the Eligible Depositors via the email address provided and registered for registration for eStatements.
7. Bursa Malaysia reserves the right to validate the email addresses provided by the Eligible Depositors before issuing the TnG Reload Pin to Eligible Depositors.
8. TnG Reload Pins are given on an “as is” basis and are not exchangeable for cash, or other items in kind, and are not transferable.
9. Bursa Malaysia will not be held liable or responsible for any late, misdirected, lost or unsuccessful efforts to disseminate the TnG Reload Pin to the Eligible Depositors. Bursa Malaysia shall have no liability for any Eligible Depositor’s failure to receive the TnG Reload Pin due to spam, junk e-mail or other security settings, email services or interruption in the internet connection.
10. Eligible Depositors are solely responsible for any taxes, levies and fees payable as a result of the TnG Reload Pins received.
11. All risks associated with the use of the TnG Reload Pins shall be assumed by the Eligible Depositors.
12. Bursa Malaysia reserves the right to substitute the TnG Reload Pins with that of equivalent or similar value at any time without prior notice.

15. Any personal data submitted as part of Campaign 2.0 will be processed in accordance with the Personal Data Notice on the Bursa Anywhere mobile application.

#### **General Terms and Conditions**

16. Bursa Malaysia reserves the right to withdraw, cancel, suspend, extend or terminate Campaign 2.0 and/or to vary, delete or add to any of the Terms & Conditions. To the extent permitted by law, any cancellation, termination, withdrawal or suspension of Campaign 2.0 will not entitle the Eligible Depositors to any compensation against Bursa Malaysia for any and all losses or damages that may be suffered or incurred by the Eligible Depositors as a direct or indirect result of the act of cancellation, termination, withdrawal or suspension.
17. To the extent permitted by law, Bursa Malaysia's decision on any matters relating to Campaign 2.0 shall be final, conclusive and binding and no further correspondence, appeals or attempts to dispute the same will be entertained in any event.
18. Bursa Malaysia reserves the right at its sole discretion to disqualify any Eligible Depositor(s) that it determines to be tampering with the entry process, or to be acting in breach or potential breach of these Terms and Conditions.
