

**ESG CAMPAIGN**  
**TERMS AND CONDITIONS**

**CAMPAIGN PERIOD**

1. The following Terms and Conditions shall be applicable to Public Investment Bank Berhad (20027-W) (“PIVB”)’s “ESG Campaign” (hereinafter referred to as “the Campaign”) which shall be held from 1<sup>st</sup> October 2023 to 31<sup>st</sup> December 2023, both dates inclusive (hereafter referred to as “Campaign Period”).

**ELIGIBILITY**

2. The Campaign is opened to all new and existing PIVB individual clients who trade FTSE4GOOD Bursa Malaysia (“F4GBM”) Index (“ESG”) stocks via online or offline with PIVB (hereinafter referred to as “Clients”).
3. The following persons shall **NOT** be eligible for the Campaign:
  - 3.1 Institutional and corporate clients,
  - 3.2 External margin clients,
  - 3.3 Permanent and/or contract employees of PIVB, their respective spouse and their immediate family members (i.e. children and parents),
  - 3.4 PIVB Remisiers, their respective spouse and their immediate family members (i.e. children and parents) and
  - 3.5 Capital Markets Services Representative’s License Holders.
4. Clients who traded ESG stocks during the Campaign Period will be eligible for the Campaign automatically. The said Clients need not apply to PIVB to be considered for the Campaign.

5. Clients who traded ESG stocks listed in **Appendix I** during the Campaign Period and meet the minimum gross brokerage threshold will be rewarded with ESG shares of their choice based on the following category.
